## **109 MINUTES OF MEETING**

Cllr Jones proposed the acceptance of the minutes, Cllr Place seconded this proposal and the minutes of the meeting held on 18<sup>h</sup> October 2012 were accepted unanimously as a true record and signed off by the chair.

## **110 MATTERS ARISING**

Cllr Hansford queried the comments made on Japanese Knotweed and what we can do about the problem. Cllr Aubrey noted that the presence of JK could affect future mortgage applications. Cllr Hood-Williams noted that trials are planned within the CCS area using a bug to eat the JK.

The clerk distributed a letter for information

- (91) Hedge cutting on chapel Rd, the trees have been cut on the side but not on the top. Cllr Place noted that this hedge needs to be maintained
- (91) Cllr Jones noted that the moss on the roof had not yet been removed. The clerk is to contact the contractor ECA on this matter and apply a 2wk deadline
- (91) SSE have been appointed as our energy supplier, The Clerk thanked Cllr Hansford for assistance in this matter
- (95) The issue with the LHCC accounts for 2011/2012 is ongoing the internal auditor does not yet have all the required information. Cllr Hood-Williams to progress this matter
- (98) Cllr Jones to follow up on the lighting issue
